This really needs to be made the most of with any new development at the bus station site. Restaurants at that site would enhance the night time trade that is currently deemed lacking in Gosport, and with the amazing harbour views would surely be a success. I feel any kind of high rise residential building would not be appropriate and only the residents in it would benefit from the location and views and that wouldn't bring in the revenue that is deemed necessary for the town, whereas restaurants/bars would. There could be residential floors above any restaurants etc, but I feel only a building of 3/4 stories high would be in keeping and not put the Falklands Gardens into shade for large parts of the day, a concern of many who enjoy the gardens and it's views.
