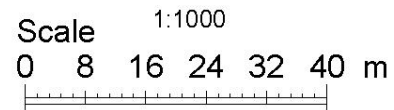

Concluding comments	The site has the potential to accommodate a limited number of new dwellings provided that local parking requirements could be addressed. That said, the site has been assessed as unable to accommodate 5 or more dwellings. Any potential future development would need to provide the parking capacity for existing dwellings and proposed, and carefully consider neighbouring amenity. As a result it is considered unlikely that the site could achieve 5 dwellings.
