

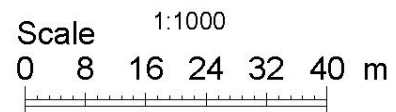

Concluding comments	The site is considered suitable for a limited amount of residential development. If the site boundary was extended to the adjacent green space, the developable area could increase to 0.08 ha and potentially enable a total of 4 dwellings. The site has however been assessed as unable to accommodate 5 dwellings and is therefore not suitable for inclusion in the SHLAA. Any potential future development would be required to meet local parking requirements.
