Royal Clarence Yard and the Retained Area	This is a very underused area, with very confusing car parking, thus emphasizing its over building, units still haven't been opened. Gosport is going to be at a total standstill, with no benefits to the residents.
North of the High Street	Sounds very congested and it is taking away the basic look of Gosport, so grateful the High Street skyline is protected, any new buildings should be instructed to blend in. Hope the seating in the High Street is more useable, many can't sit in the existing seating. The bike racks are more inappropriate than the old ones, and have been placed in the wrong places for the users.
The High Street and associated areas	Maintain the original look of the High Street, any new buildings to blend in, no modern design that stands out like a sore thumb. All passageways to be retained, they are Gosport Heritage and enough has been lost over the past 10 years.
South Street	Shopping units with two storey buildings above would be suitable providing there is sufficient parking for the working and customers.
Trinity Green area	If housing is built here, parking with two storeys on top that blends in with the vision of the waterfront should be built to enhance Gosport but should be tradition and not modern.
Haslar Marina	What do the yachtsmen need, do we really need expansion? after all we are reducing areas for the boatmen in Mumby Road.
The Gosport Lines	This needs to be sympathetically addressed, in traditional brick, and should be available for the retired and elderly so they can get the full benefit of the town, and would release more larger houses throughout the town for families.

8. Is there anything in the SPD that particularly concerns you and why?	There are a number of Georgian buildings around Gosport, this should be the basis for any buildings. We do not need any more tower blocks as Gosport is already at saturation point. Any houses/flats sold should have a caveat that states only home ownership, or landlords will take them over and charge exorbatant rents so they will no longer be affordable to the residents of Gosport

10. Please can you give any suggestions of what else the Council should consider to include in the final version of the SPD?	Listen to what the residents of Gosport would like - no modern glass buildings that will do nothing to enhance Gosport, we need brick buildings that will last for future generations. The voice of the people of Gosport is more important than consortium profits or we will be here again and again.
11. Please include any comments you may have	There should be an embargo so no more buildings are allowed to be built for the next 20 years, or we will be losing all our younger generation, they do not want to live in a concrete estate with no facilities nor green areas, we cannot encourage a wider range of shops with no foot fall, and this is already evident, it will only get worse if we build any more. There are many full-time working couples in Gosport, who can't get on to the housing ladder, whilst paying such high rents, so no more luxury flats - consider the majority of the residents of Gosport.
