A key additional strength which seems to be unnoticed is the potential access to the water for water users, which is hampered by the currently layout.

I agree strongly with the lack of connectedness between areas (e.g. Falkland Gardens to Royal Clarence yard). Additionally a key weakness is a lack of access to the water for water users. There is for instance no public hard or pontoon. Gosport as a town is a closed shop to private users of the harbour, except for those using marinas, but these remain disconnected from the town and the community. A further weakness is the lack of clear pedestrian and cycle access to large portions of Gosports waterfront - Gosports greatest asset.	
4. Do you have any comments regarding the opportunities of the Waterfront and Town Centre area identified in the SPD? (eg. agree, disagree, any additional ones?)	Opportunity to re-introduce public access to the water - slipways, pontoons, a public hard - which would be a return to the heritage of Gosport, add to its attractiveness, add to the potential for visitors, and provide waterside activities (e.g. crabbing for kids). Agree strongly with the desire to extend current waterside walkways / cycle paths. It would be a huge benefit to make a waterside pathway through the boatyards, and then following the waterfront round to Royal Clarence yard.	
5. Do you have any comments regarding the challenges of the Waterfront and Town Centre area identified in the SPD? (eg. agree, disagree, any additional ones?)	The challenge is balancing competing aims. Water access must not be sacrificed for the sake of residential developers. This has happened at Harbour Road where vehicle access to the slipway has been effectively removed due to the development of retirement flats. This was one of the last places you could launch a kayak along the Gosport waterfront but even after the development is complete all hope of parking in the vicinity will be effectively lost.
