I am not sure that you can justify losing quite so much parking especially if you are trying to encourage more people to use the town. My biggest concern is the bus station site. I like the idea of re-developing this eyesore but am hugely concerned at the plan which would seem to indicate a rather tall building. This is going to be the first thing people see of Gosport and being confronted with a huge building will not be welcoming irrespective of what commercial properties you might have on the ground floor. I believe that the number of slots available to buses can be reduced from the number we currently have and probably only need 1 coach stop. There is definitely a need to a coffee shop/caf? which has the ability for people to sit and admire the harbour area. I cannot see what improvements are needed in the Falkland gardens. These are a lovely area and should be retained as is. Also the route from Town to Ferry or Car to Ferry or Taxi to Ferry or Bus to Ferry are, in themselves, well worth keeping.
